#### The Process

During the audit process, your workers and contractors will receive 2 emails from PayslipBuddy:

- The **Onboarding Email** as soon as we receive the first Payslip via API.
- The **Payslip Audit Report Email** as soon as a payslip is received via API.

# Onboarding Email

## The Process

The onboarding email is sent to the worker only once. It is sent immediately to a worker after receiving the first payslip.
